Purpose of National Honor Society

National Honor Society Eligibility

• Juniors and seniors who have a cumulative GPA of 95.00 or higher at the end of the 1st semester will be notified and invited to apply at the beginning of the 3rd marking period.

• Applicants are evaluated according to Four Pillars:

Scholarship

Leadership

Service

Character

- Students must receive at least 20 points to be accepted into NHS.

Scholarship

Students invited to apply already meet the requirement for Scholarship. Students are further evaluated to see if they meet or exceed the requirement:

Leadership

Leadership includes:

- Leadership positions elected or appointed leadership positions held in school, community, or work activities. (Examples: class officer, team captain, work area manager)
- **Membership in Activities:** An activity could be a sport, club, musical group, committee, job, etc.

Service

- Service activities are those that are done for or on behalf of others (not including immediate family members) for which no compensation (money or other) has been given.
- Include service (volunteer) hours performed in school and/or community beginning in grade 9. These can be individual or group service projects.

Character

• Evaluation of candidate's character includes three areas:

- Faculty recommendation of character traits
- Discipline reports
- Attendance record

Written Response (Essay)

- A Written Response is a requirement.
- Candidates will be given a prompt to answer. It will be written in school during a flex period.
- The Written Response will be evaluated by the NHS Faculty Committee.

Letter of Recommendation

OPTIONAL Letter of recommendation from someone who is not in your family and not a teacher in our school district with a specific example of how you embody one pillar of National Honor Society.

Evaluation by NHS Faculty Council

All Candidate Information forms, Essays, and Letters of Recommendation are evaluated by the NHS Faculty Committee of 5 teachers, which are appointed by the Principal each year.

The Faculty Committee uses the NHS Rubric.

The Principal will review the applications of all candidates not selected for membership.

Timeline

- <u>Beginning of third marking period</u>: Students who meet requirements are invited to apply. All students meeting requirements will be given an application packet (Candidate Information Form)
- <u>February 25th (tentative)</u>: Deadline to submit Candidate Information Form
- Week of March 11th (tentative): students will be notified of decision
- <u>March 21st</u> (tentative): NHS Induction Ceremony
